Dear Parade Participant,

It is our pleasure to invite you to participate in the **2023 Magnolia Summerfest Seafair Parade**. The parade date is **August 5th, 2023**. The parade begins with a kid's parade scheduled at **10:00 am** followed by the main parade featuring marching bands, drill teams, and more! This year we have designated performance areas to include the entire parade route.

Parade Staging and Route: (see attached maps)

Parade line-up begins at 34th Ave W and W Raye St. The parade runs South on 34th Avenue West, turns East on W McGraw St and turns North on 32nd Ave W, with dispersal after W Raye St. Assembly for the Kids Parade will be on W Raye St between 34th and 35th Ave W which is accessed via 34th Ave W. Dispersal will be in the NE parking lot of Catherine Blaine Elementary School which is accessed via 32nd Ave W.

Application Requirements:

Enclosed is an application packet. The City of Seattle and the Magnolia Chamber of Commerce require that each participant sign a **Hold Harmless Agreement**. Your representative may sign for a group, but all children under 18 need to have their own form with parent/guardian signature. Either return all of the Hold Harmless forms with the application or bring them on parade day.

Any motorized unit must provide a copy of **proof of insurance certificate** with your application.

Commercial entries must provide **proof of liability insurance**.

If you would like more information or have any questions, please don't hesitate to email or call. We sincerely hope that you will be able to include our parade in your plans for your 2023 season.

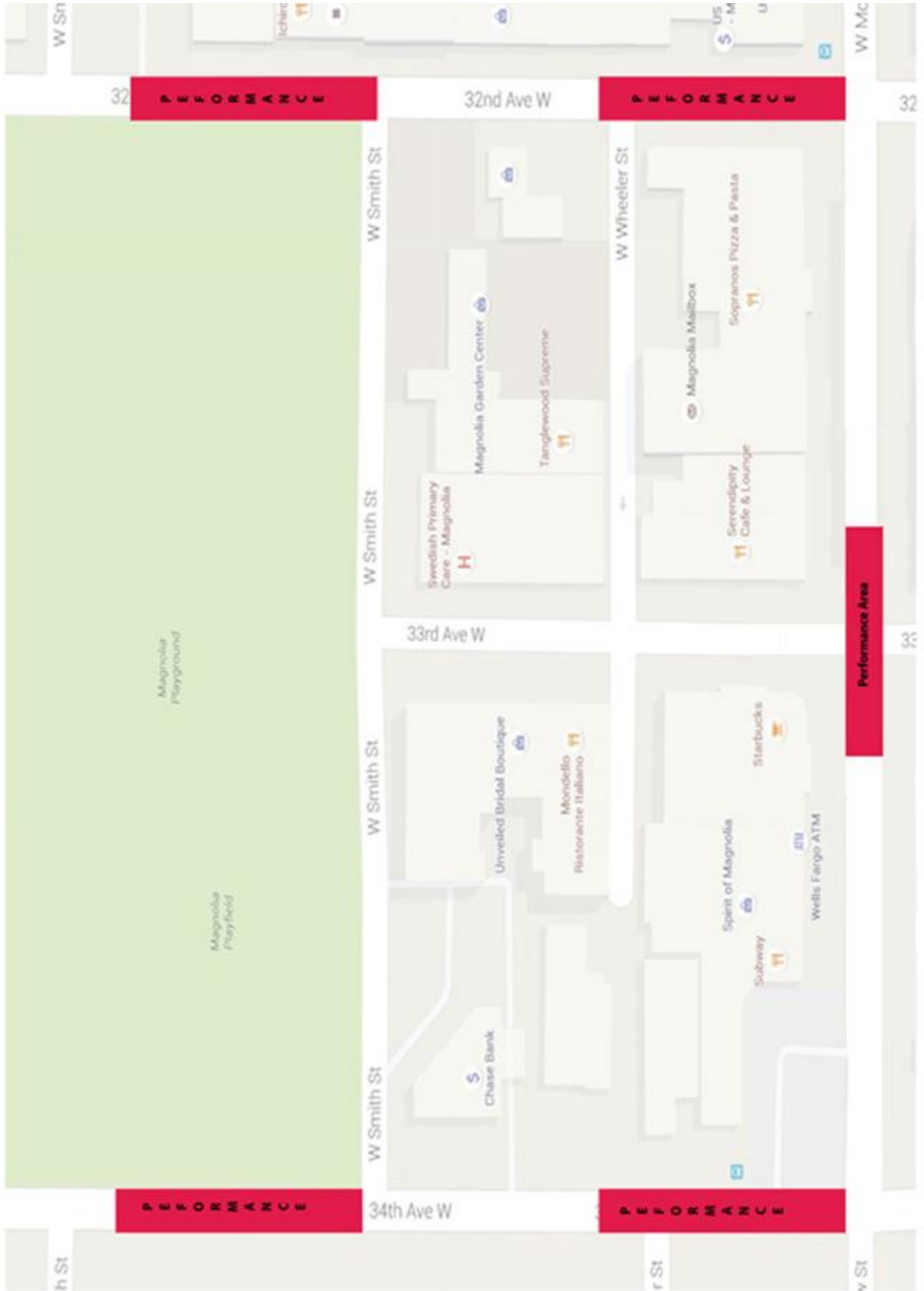
